# JUDGMENT(S) OR LIEN(S)

A judgment(s) or lien(s) over \$500.00 appearing on your credit report <u>must be paid IN FULL</u> before the Board can issue the license.

#### **Required Documentation:**

<u>For STATE TAX LIENS</u>: A letter of release from the Alabama State Department of Revenue (ADOR) indicating that payment for the tax lien has been received and the lien is scheduled for release. Contact ADOR's Collection Services at (334) 242-1220.

<u>For FEDERAL TAX LIENS</u>: A letter of release from the Department of Internal Revenue Service (IRS) indicating that payment for the tax lien has been received and the lien is scheduled for release.

**NOTE:** The case number of the tax lien on the release letter from the

ADOR or IRS must match the case number reflected on the

credit report.

If you do not have a satisfaction and release of the judgment or lien, the Board MAY accept other evidence that the judgment or lien has been paid, such as a copy of the receipt or cancelled check (front & back) indicating payment of the judgment or lien.

<u>For DISPUTED JUDGMENT OR LIEN</u>: Send a written explanation of the dispute and copies of any letters or faxes that you have sent to the creditor.

### **BANKRUPTCY**

### **Required Documentation:**

#### PENDING BANKRUPTCY:

- CHAPTER 7 OR 11: Your written explanation <u>and</u> the list of creditors included in the bankruptcy.
- CHAPTER 13: Your written explanation, a list of creditors included in the bankruptcy, a copy of your payment plan, and a history of your payments.

<u>DISMISSED BANKRUPTCY:</u> A copy of the order of dismissal, evidence of the conversion or re-filing of the bankruptcy, documents to show whether the creditors included in the dismissed bankruptcy are also included in a pending bankruptcy, and a written explanation.

<u>DISCHARGED BANKRPUTCY:</u> A copy of the order discharging the bankruptcy.

Note: Your bankruptcy trustee can provide you the list of creditors and copy of your payment plan and history of payments, as well as a copy of a discharge.
