Your fee must be paid before your application will be processed. **The deadline for renewal applications is November 30, 2022.** A \$50.00 late fee must accompany any renewal application postmarked* on or after December 1, 2022. **Your 2022 license expires December 31, 2022.**

*The term "postmarked" means postmarked by the U.S. Postal Service, not metered.

NOTICE: Submitting false information for the purpose of obtaining a license is a criminal offense and grounds for license denial. An individual license allows only the individual to engage in residential roofing.

CONTINUING EDUCATION REQUIREMENTS: All licensees under the age of 60 as of October 1, 2022 (individual renewal applicants and/or the designated qualifying representative for corporate renewal applicants) must have completed six (6) credit hours of continuing education. Licensees submitting a renewal application for the first time are not required to complete continuing education.
