Date of Action: January 25, 2024

Disciplinary Action File Number: CC 23-092

Disposition: Licensee was charged with incompetence and misconduct in violation of Ala. Code § 34-14A-8 (1975) and no written contract in violation of Ala. Code § 34-14A-7(f) (1975) and Ala. Admin Code r. 465-X-1-.01(12)(a)11.

Prior to the date and time set for a hearing, a settlement was reached.

Licensee agreed to a \$5,000 administrative fine and complete twelve (12) hours of builder education.
