By Order of the Home Builders Licensure Board, June 26, 2025

Date of Action: June 26, 2025

Disciplinary Action File Number: CC 24-070

Disposition: Licensee was charged with a violation of the Act for engaging in residential home building through an unlicensed entity pursuant to Ala. Code § 34-14A-8(1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$1,000 administrative fine and six (6) hours of builder education.**

Noel Ray Forsythe, License No. 14366

Date of Action: June 26, 2025

Disciplinary Action File Number: CC 24-107

Disposition: Licensee was charged with a failure to use a valid, written contract, failure to perform residential homebuilding in a reasonable manner, and failure to disclose the status of his general liability insurance in violation of Ala. Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to surrender his license.**

Disposition: Licensee was charged with a failure to use a valid, written contract and a failure to disclose the status of its general liability insurance in writing and signed by both parties in violation of Ala. Code § 34-14A-8 (1975) and Ala. Code § 34-14A-19 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$1,000 administrative fine and six (6) hours of builder education.**

Disposition: Licensee was charged with a failure to disclose the status of its general liability insurance, in violation of Ala. Code §§ 34-14A-8 and 34-14A-19 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$2,500 administrative fine and six (6) hours of builder education.**

Disposition: Licensee was charged with violations of the Act for misconduct and failure to use a valid, written contract pursuant to Ala. Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$10,000 administrative fine and six (6) hours of builder education.**

Disposition: Licensee was charged with misconduct in the performance of residential home building in violation of Ala. Code § 34-14A-8 (1975) and failure to use a valid written contract in the performance of residential home building in violation of Ala. Code § 34-14A-7(f) (1975) and Ala. Admin Code r. 465-X-1-.01(12)(a)11 in these matters. Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a one-year suspension; the suspension to be held in abeyance conditioned upon the terms of the agreement which include an administrative fine of \$10,000 for BC 24-039 and \$10,000 for BC 24-041, complete twelve (12) hours of builder education, and although age-exempt, annually complete six (6) hours of continuing education for three years.**
