Date of Action: August 28, 2025

Disciplinary Action File Number: CC 23-124

Disposition: Licensee was charged with a failure to disclose the status of its general liability insurance and misconduct in violation of Ala. Code §§ 34-14A-8 and 34-14A-19 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$1,500 administrative fine and twelve (12) hours of builder education.**

Date of Action: August 28, 2025

Disciplinary Action File Number: CC 24-101

Disposition: Licensee was charged with a failure to use a valid, written contract, failure to perform residential homebuilding in a reasonable manner, and failure to disclose the status of his general liability insurance in violation of Ala. Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$5,000 administrative fine and twelve (12) hours of builder education.**

Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$9,000 administrative fine and twelve (12) hours of builder education.**

Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$500 administrative fine.**

Disposition: Licensee was charged with engaging in residential home building through an unlicensed entity, a violation of the Act, a failure to use a valid written when engaging in residential homebuilding in violation of Ala. Code § 34-14A-7(f) (1975), gross negligence in the practice of residential home building in violation of Ala. Code § 34-14A-8 (1975), and a failure to disclose the status of his general liability insurance in violation of Ala. Code § 34-14A-19 (1975). Prior to scheduling a hearing, a settlement was reached. **Licensee agreed to a \$8,000 administrative fine and twelve (12) hours of builder education.**
