Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$500.00 administrative fine and twelve (12) hours of builder education.**

Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$500.00 administrative fine and six (6) hours of builder education.**

**Disciplinary Action File Number:** BC 24-028

**Disposition:** Licensee was charged with engaging in residential home building business through an unlicensed entity, failure to use a valid written contract in the performance of residential home building, failure to perform residential home building in a reasonable manner, and gross negligence in the practice of residential home building in violation of Ala. Code § 34-14A-8 (1975). Prior to the date and time set for a hearing, a settlement was reached. **Licensee agreed to a \$12,500 administrative fine and twelve (12) hours of builder education.**
